<p><b>ITEM 100</b></p> <p align="center"><b>CAPITAL PROJECTS SURCHARGE FEE</b></p> <p>In addition to the transportation charge or charges published in tariffs or other instruments whatsoever, the per car surcharge rates shown below shall be used for the purposes of calculating Capital Project Surcharge Fees on traffic moving to or from stations on the CBR assigned ZONES A, B, C and D:</p> <p>1. Except as provided for in (2) below, the following per car surcharge rates will apply:</p> <p>(a) ZONE A..... \$50.00            (b) ZONE B..... \$75.00            (c) ZONE C..... \$85.00            (d) ZONE D (Crossing the Coos Bay Bridge). \$100.00</p> <p>2.
