Letter suffixes will be used in alphabetical sequence starting with A. <p><b>ITEM 40</b></p> <p align="center"><b>TERMINAL CHARGES, TRANSIT ARRANGEMENTS OR OTHER PRIVILEGES</b></p> <p>Freight transported under this tariff, in addition to rates named herein, will be subject to such charges and entitled to such privileges as are set forth in tariffs published by the Lake Superior &amp; Ishpeming Railroad Company relating to car service, inspections, reconsigning, storages, switching, weighing or other transit or terminal privileges or requirements which in any way increase or decrease the value of the service to the shipper.</p>	<p>Note 1: Rate includes spotting of empty cars at mine origin, pulling loaded cars and weighing and adjusting lading to meet minimum and maximum load limits.</p> <p>Note 2: Trains of 51 - 70 cars are limited to non-vessel season (approximately January 15 - March 25) only or otherwise with prior approval of LSI.</p> <p>Note 3: Minimum 48 hour notice must be given to switch from normal trains (41 - 50 cars) to longer trains of (51 - 70 cars.) If no notice is given to load longer trains, a maximum of 50 cars will be accepted to load. Notice can be given for set period of time. Also, minimum 48 hour notice must be given to switch from loading longer trains (51 - 70 cars) to normal trains of (41 - 50 cars.) If less than (51 - 70 cars) are tendered for loading prior to or during the 48 hour notice window the (51 - 70) car rate will apply to shorter train.</p>
